

1. SERVICES PROVIDED BY THE PROVIDER

The provider shall supply the customer with the products ordered in the contract. This is subject to the property being connected. The provider reserves the right to change the range of programs, in particular as a result of programs being discontinued or due to requirements imposed by the broadcaster, changes in technical distribution, changes in customer requirements, official orders, etc. The provider is in no way responsible for the content transmitted.

2. CONTRACT TERM AND TERMINATION

This contract shall enter into force upon signature. The contract may be terminated by either party with 3 months' notice. In the event of a promotion, the contract may only be terminated after the promotion has expired with 3 months' notice. Terminations must be made in writing and at the end of a month. Mobile subscriptions including mobile devices have a minimum contract term of 12 or 24 months and can be terminated after the minimum contract term has expired with 3 months' notice.

3. TERMS OF PAYMENT

The operating costs are payable monthly.

4. LATE PAYMENT

If the customer fails to meet their obligations despite receiving a reminder, the provider is entitled to interrupt the transmission of the products. The provider will charge a reminder fee of CHF 20 from the second reminder onwards. The provider reserves the right to assert the remaining claim and the costs for the interruption (sealing).

5. TARIFF ADJUSTMENT

The provider is entitled to unilaterally change and adjust the tariffs. If the customer does not agree with the adjustment of the subscription prices, they may terminate this contract by registered letter at the time of the adjustment.

6. MISUSE

The removal of seals, connection to the broadband communication network in any form, or extension of the installation outside the contractual agreement are considered misuse and may be prosecuted. In addition, the provider shall be entitled to full compensation for damages.

7. ACCESS FOR INSTALLATIONS AND INSPECTIONS

The provider or its representatives are entitled to enter the connected premises after giving at least 48 hours' notice and to carry out the necessary clarifications, sealing, inspections, etc.

8. RECEPTION LICENSES

The federal license fees for radio and television are to be paid by the individual customer directly to the designated collection agency.

9. SEALING AND UNSEALING

When moving house, the necessary sealing and unsealing is carried out free of charge.

10. DEVICE SETTINGS

The provider is not responsible for setting up or programming radio and TV devices, video devices, etc. For device settings, the provider requests that its customers contact a radio and TV dealer directly.

11. CHANGING RESIDENCES

The customer must notify the provider in writing of any change of residence thirty days before moving out, stating the new address.

13. LINES AND INSTALLATIONS

The provider uses the lines and installations of DANET AG.
